



## EBBC Contributes to Casino Transportation Impact Study

Three Indian Casino proposals for West Contra Costa County threaten to degrade bicycle access and safety by generating tens of thousands of trips on local streets and roads. In order to challenge the gaming juggernaut promoted by Governor Schwarzenegger, the EBBC was invited by County Supervisors Gail Uilkema and John Gioia to join an Ad Hoc Committee for Mitigation of Off-Reservation Impacts of Tribal Casinos that seeks to document the broad transportation impacts of the casino proposals.

At the August 18, 2005 General Meeting, EBBC members elected to invest \$3000 in the transportation impact study. We are not gambling with your precious contributions. One condition we require is that the study results in useful data that will help us implement bikeway plans in the area. We further recognize the opportunity to set an example for truly comprehensive transportation analyses that routinely consider impacts on bicyclists. The EBBC will further be represented on the Steering Committee that monitors the consultant's work and acts as a liaison to the Ad Hoc Committee.

The Ad Hoc Committee met on September 22, 2005 and agreed to move forward with the Regional Traffic Study using a phased approach, based on funding commitments/pending commitments from Contra Costa County, Marin County, Hercules, Pinole, El Cerrito, Novato, Albany, Doctors Medical Center, East Bay Bicycle Coalition, and the East Bay Regional Park District. A

full analysis could cost over \$300,000 according to preliminary work done by County staff and a consultant. The West Contra Costa Transportation Advisory Committee (WCCTAC) will act as the "fiscal agent" for the traffic study and issue an RFP in October. Work could commence by November 15.

Indian gaming has blossomed throughout the US since a 1988 Supreme Court ruling opened the door for tribes to operate casinos. Casinos soon appeared on distant reservations, but landless tribes like the Pomo, had to wait for more recent federal and state legislation to develop sites in urban areas. The proposed venues will not offer your grandmother's sociable weekly bingo game. The electronic games are focused on individuals, around the clock, who often develop gambling addictions with profound consequences for families and society. Governed by the Federal Bureau of Indian Affairs, the rules for tribal casino development limit the extent of mitigations and pose a procedural process that local jurisdictions have no experience grappling with. Hence, our unprecedented contribution to a traffic analysis. It should be noted, however, that the EBBC was part of a broad coalition of groups that halted a casino proposal next to the pristine Arrowhead Marsh and Bay Trail in Oakland earlier this year.

### Casino Proposals

The I-80 Bikeway represents a signed regional route from El Cerrito del Norte



BART to Rodeo. Southbound bicyclists traveling on San Pablo Dam Road are already impacted by the existing San Pablo card room that recently installed hundreds of electronic bingo machines. Because bicyclists cannot legally turn left onto Amador to continue toward the Key Route and BART, they must cross I-80 and make a u-turn in front of the burgeoning casino parking lot before climbing past on-ramps and again crossing I-80 toward Amador. Plans to replace the I-80 crossing by Caltrans reflect the input from EBBC members who have pressed for this crucial improvement since 1997. However, according to Adele Ho with the City of San Pablo, the State funding remains in limbo and there is no date set to begin the project.

The *Contra Costa Times* (9/18/2005) reported on a scenic hike on the Point San Pablo shoreline and ridge led by Richmond trail advocate David Dalberg. "There is a consensus there should be a regional park on this peninsula," said Dalberg. How the long-sought park can co-exist with the proposed Indian casino on the peninsula north of the Richmond-San

## BART Declares Maps and Schedules to be Proprietary

Threatens legal action against publisher of free BART schedule application for popular Apple iPod

In one of the stupidest cases of government censorship, BART has sent a cease and desist letter to William Bright, owner of the popular *ipodsubwaymaps.com* web site. Bright's web page provides a free downloadable subway map and schedule of the BART system for the ubiquitous Apple iPod.

Given BART's continuing budget and ridership woes, one might expect the district to commend Bright for taking the initiative to increase the user-friendliness of BART. Instead, the district has demanded that Bright remove images of the BART map, logo, and other "intellectual property".

BART's letter states: "*There is a widespread belief that materials published by public agencies such as BART are in the public domain. This belief is incorrect.*"

Note also that BART's brochures, including the fare and schedule guide, are provided on its web site in Adobe .pdf format for viewing — but the files utilize the pdf *password-protection* feature to prevent any "unauthorized" copying of information.

BART spokesman Linton Johnson states that the agency is working on its own downloadable version of subway maps for "iPods and other portable devices." But given that the buggy *bart.gov* web site still cannot produce correct timetables, developing a competitive iPod offering might be beyond the capabilities of BART's IT staff.

The idea that California government agencies can restrict the flow of information through copyright will have a chilling effect on our open government laws. At the Federal level, agencies are not allowed to copyright documents, except in rare cases where specifically permitted to do so by law. At the state level, there is no such blanket restriction — though agencies are prohibited from placing restrictions on copying of "public records."

## SHORT REPORTS

**CALTRANS GRANTS** – An Oakland Caltrans Transportation Planning Grants Workshop on August 23 was not held early enough for Nancy Baer, Manager, Injury Prevention and Physical Activity Promotion Projects Contra Costa Health Services (925-313-6837). Ms Baer traveled to Redding to attend a similar workshop held prior to the Oakland session and get a head start on her application to promote walking and bicycling. The EBBC has previously submitted an application for the Coliseum BART to Bay Trail connector, but we need a governmental sponsor to resubmit. Four or five other project ideas backed by the EBBC will need to wait for the next round of funding.

**ALAMEDA COUNTYWIDE BICYCLE PLAN UPDATE** - Led by the Alameda County Congestion Management Agency (CMA), the update is now underway. The CMA's Technical Advisory Committee (ACTAC) meets with members and staff from ACTIA's BPAC and other agencies and interested parties on the first Tuesday of the month, from 11:30 to 1:30 in the CMA Board Room, 1333 Broadway, Suite 220, Oakland. **RICHMOND BAY TRAIL** - Thanks to TRAC's advocacy promoting a donation by Auto Warehousing Company and a grant from Association of Bay Area Governments (ABAG) Bay Trail Project, construction design is fully funded at \$148,000 for Bay Trail access to historic Kaiser Shipyard 3 in Point Potrero Marine Terminal located at the foot of Canal Blvd. Shipyard 3 is scheduled to become a centerpiece of the Rosie The Riveter/ WW II Home Front National Historical Park because it is the only place where a rich concentration of diverse WW II ship building facilities still remain. **EL CERRITO BART RETROFIT** – Recent passage of the BART Seismic Retrofit Bond will lead to disruption of bikeways adjacent to aerial BART tracks. The City of El Cerrito has invited the EBBC to co-sponsor a planning grant application that will: 1) provide detours for bicyclists when construction disrupts access on the Ohlone Trail; and 2) plan for improvements to the Ohlone Trail following completion of the retrofit work. **RICHMOND** – Carlson Blvd will be rebuilt to remove the extreme crown height. At a well-attended Richmond Annex neighborhood meeting on September 22nd, the EBBC's suggestion to reconfigure the existing 4-lane road to add bike lanes and improve pedestrian safety received community support. **EMERYVILLE** - The City of Emeryville's General Plan Update Steering Committee held a panel discussion on local Pedestrian and Bicycle issues on September 27, 2005 at 6:30 pm. **ROUTINE ACCOMMODATION** – The MTC completed their survey of how well local jurisdictions provide for the needs of bicyclists and pedestrians. The draft report included recommendations for how to implement routine accommodation as spelled out by Caltrans' Deputy Directive (DD-64) and Federal Highway Authority policies. Rafael Bridge is unclear. As a result, the East Bay Regional Park District has sued the city and the casino developer over the casino plan.

While Dalberg practices diplomacy with a hope to extend the Bay Trail and create the park—even if the casino is built—the truth is that overall bicycle access and safety in the area will suffer and the park experience will be degraded if the casino moves forward. Sharing the road with thousands of gamblers is not an appealing prospect for bicyclists. Nor is the peninsula convenient for the many Richmond workers that do not drive. And finally, the added traffic on the Richmond-San Rafael Bridge will surely require additional State highway expenditures/subsidies on both shores while scuttling the prospect of converting the superfluous third lane into a bikeway that retains the maintenance, breakdown and traffic enforcement functions that currently exist.

The draft EIS for the Scotts Valley Band of the Pomo Indians project in North Richmond—the so-called “Sugar Bowl” proposal—has not yet been released. It will be posted on the County’s Website ([www.cccounty.us](http://www.cccounty.us)) under County News – What’s New. A 60-day comment period on the draft EIS is expected. The unincorporated site on the Richmond Parkway is certain to further reduce the bicycle access options along the Parkway. The parallel pathway that was proposed when the Richmond Parkway plans were adopted in 1990 remains to be built. It is also doubtful that either the Bay Trail through the nearby Brunner Marsh or the circuitous on-street bike routes through the area will benefit from increased traffic.

Sara Hoffman, Chief of Staff for the Supervisors best summarized the situation to the Ad Hoc Committee when she stated, “casinos are not appropriate for this region, the best way to mitigate is to not build.”

**BART-SAN JOSE** - When the VTA last submitted projected ridership numbers for a San Jose BART extension, they were far too low to qualify for Federal funding: the FTA gave the project a "Not Recommended" rating. The VTA has now released a new study for the \$6 billion(!) project giving a new estimate of 110,000 daily trips — up from the previously projected 87,200. The VTA claims the increase comes from newer ABAG projections. This level of ridership would put San Jose on par with the transit-oriented San Francisco financial district in terms of BART trips (overall, San Francisco has 3 times the density of San Jose). Or to put it another way: the San Jose BART extension would carry as many riders as the Los Angeles Red Line, which goes through the extremely busy Wilshire corridor.

**BART-OAK** - A proposed monorail to connect Coliseum BART with the Oakland Airport has run into more cost overruns. It is now \$70 million short, leading the Port of Oakland to take the unprecedented step of seeking private investment for the project. It is not entirely clear how bonds would be paid off — BART does not turn a profit and requires public subsidies. One suggestion is to implement a \$5 surcharge for the short trip. Currently, AirBART shuttlebus service costs \$2, and AC Transit bus service to the airport cost \$1.75. It should also be noted that the SFO BART extension had been predicted to turn a profit, but in fact runs a considerable deficit due to low ridership.

**BIKE/PED BRIDGE TOLLS** - AB 748 would have prohibited agencies from charging a toll to "any bridge or highway that is part of the state highway system." It was passed by the Legislature in response to a proposal by the Golden Gate Transit District to charge a toll for bikes and pedestrians to cross the Golden Gate Bridge. Governor Schwarzenegger voted the bill, stating it would inappropriately usurp control from local agencies.

**\$17 MILLION BIKE TUNNEL** - In a unanimous vote, the Marin County Board of Supervisors approved plans for a bike tunnel connecting the San Rafael Transit Center to the Larkspur Ferry Tunnel. The vote clears the way for \$1.25 million in preliminary engineering work.

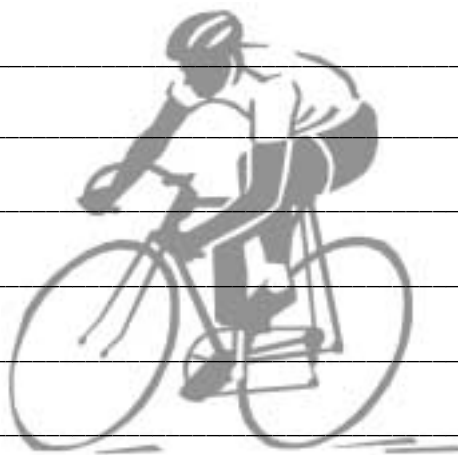
