I-880 Widening to Cast Shadow Over Oakland

Caltrans is required to get a permit from the Bay Conservation and Development Commission construct over the Lake Merritt Channel their "seismic retrofit" replacement of the 5th Avenue Overcrossing that will widen the freeway by 50-feet. Caltrans made a presentation to the BCDC Design Review Board last fall, and no one from the City of Oakland attended. Two organizations were present in the audience, Waterfront Action and the ABAG Bay Trail project (Laura Thompson). We expressed our concerns about safe access to the waterfront across the railroad tracks. The Design Review Board agreed with our position and basically rejected Caltrans' proposal for public access improvements. The permit application is slated to go before the BCDC Commission on March 17, 2005.

Waterfront Action is working with various groups to identify feasible projects to mitigate the problems associated with 6 years of construction disruption, plus other impacts on the environment.

The first meeting of community groups and others occurred in January. Three BCDC staff members attended, in addition to Patrick Kerr, representing Union Pacific, Pat Kernighan, chief of staff to Danny Wan, City Council District 2, and reps from Port of Oakland, the Oakland Redevelopment Staff and others. There

was a long discussion on ways to improve access at 5th Avenue for the San Antonio neighborhoods.

A second meeting on February 18, 2005 added representatives from the Amtrak Capitol; Kerry Jo Ricketts-Ferris, coordinator for Oakland's Lake Merritt and Estuary Projects; Peralta College; Urban Ecology and EBBC.


Everyone was in agreement that the combination of increased Capitol Corridor trains and over 3000 housing units proposed between Oak and 9th Ave along the Oakland Estuary heightens the railroad crossing risk at 5th Avenue. A 1997 proposal to build a bike/ped bridge over the railroad to connect the Lake Merrit Channel path, funded by Measure DD, with Estuary Park needs to be revisited.

Resolution Requesting the Metropolitan Transportation Commission and the California State Legislature to Fund a West Span Bicycle/ Pedestrian/ Maintenance Pathway as Part of Any Funding Plan for the East Span Replacement Project

WHEREAS the San Francisco-Oakland Bay Bridge is a crucial transportation link that is a recognized part of the 400-mile San Francisco Bay Trail, initially sanctioned in 1988 when Senator Bill Lockyer's SB 100 was signed into law and

WHEREAS the Governor of California in 1998 signed AB 2038 (Migden) to allow for a bicycle/pedestrian path to be built on the western span of the Bay Bridge using the locally generated toll-bridge surcharge money and

WHEREAS an extensive public planning process for the East Span replacement structure resulted in the inclusion of a 15.5 foot wide pathway from West Oakland to Yerba Buena Island as part of the new bridge and

WHEREAS Caltrans has provided guarantees that regardless of which East Span design is selected, that it will include a pathway for pedestrians, cyclists, and Caltrans maintenance vehicles and

WHEREAS in May of 2001, Caltrans released a major \$2 million feasibility study examining the addition of a cantile-

ver pathway or pathways to the West Span to complete non-motorized access across the Bay, and this study found that such a pathway is feasible and would have multiple benefits for Bay Area travelers and

WHEREAS a shore to shore pathway on the Bay Bridge would provide world class views of downtown San Francisco from the upper deck, be an attraction that

would draw significant additional tourist traffic to the City, and enhance the Embarcadero Promenade and

WHEREAS the pathway would benefit motorists by providing an emergency refuge in case of breakdown, and allow Caltrans crews to use the pathway for many maintenance activities, eliminating the need to close lanes on the Bay Bridge, reducing congestion and the number of collisions, and

WHEREAS a pathway on the Bay Bridge would provide an alternate access route in case of natural or man-made disaster that affected the bridge or the Transbay Tube and

WHEREAS an ambitious redevelopment plan for Treasure Island is in the works, proposing 2800 units of new housing including at least 300 affordable units, and these new residents will be relatively isolated from San Francisco and the East Bay if a pathway is not provided and

WHEREAS the pathway would be used by potentially millions of cyclists every year, traveling between Oakland and San Francisco, and is the most cost effective means to increase capacity on this heavily congested corridor

THEREFORE BE IT RESOLVED THAT the City of ______ request that the California State Legislature and Metropolitan Transportation Commission include the cost of the West Span Pathway in any funding plan to pay for the cost overruns related to the East Span replacement



SHORT REPORTS

LAKE TEMESCAL PATH – Bikeway signs have finally appeared to remove this route from the Bay Area's best kept secret list. The path parallels SR13 between Broadway Terrace in Montclair and the upper Broadway route to Tunnel Road. Hey, it's only seven years after the path was opened. It was the only "bike" project funded by the precursor to Measure B. In reality, we applaud Oakland's timely response to our complaints that the signs had recently been placed at the wrong location.

SR24 CROSSING PROPOSAL - In our unending search for feasible ways to ride directly between Montclair and Berkeley, Ron Bishop led an EBBC subcommittee on an expedition to view his at-grade alternative to a bridge crossing of SR24. Joining the group were representatives from Montclair and North Hills Phoenix Neighborhoods on either side of the freeway, plus members of the newly formed Montclair Royal Grounders bicycle group. All were pleased that we now can present Caltrans with an option to bridging SR24 from the existing abutment above Lake Temescal. With lighting of the Temescal Path, the Tunnel-Temescal Route would inspire year-round bike commuting between Montclair and Berkeley.

STATE BICYCLE FUND - In 1997 the new Bicycle Transportation Account helped build the first "road diet" (traffic lane converted to bike lanes) on Bancroft in San Leandro. The BTA is currently at \$7.2 million per year, which is approximately \$1 per year for every Californian who bicycles. Unfortunately, the BTA is scheduled to decrease to \$5 million a year in July 2006. You can help us preserve the existing funding level by writing your support for Senate Bill 523 (Tolakson). REGIONAL BIKE/PED PROGRAM received 40 project applications totaling \$35 million in requested project funds. Only \$8 million is available during the initial funding cycle.

Cycles of Change Plans Two Bike Tours

Have you ever seen a group of excited kids biking on the local streets, each of them wearing helmets and riding with impressive skill? Maybe they were riding single-file along MacArthur Blvd. on their way to Dimond Park to hike along the restored banks of Sausal Creek, or taking their bikes on BART for a ride to Coyote Hills' shellmounds, or shifting into easy gears as they worked their way up to the climbing and views of Indian Rock. Well, chances are you might have seen a field trip being led by the East Bay's fantastic youth bicycle education program called Cycles of Change.

Cycles of Change is a bicycle program for youth that was founded in 1998 by two volunteers at Roosevelt Middle School in Oakland's ethnically diverse and low-income San Antonio district. This unique program has a number of hands-on (and on-bike) services which teaches diverse groups of youth how to safely operate a bike, how to perform basic bicycle repairs, and how to work well independently and as a member of a large community of youth and adults. Using mainly donated bikes, helmets, and equipment, Cycles of Change is a year-round program which runs after-school, weekend and during school bicycle field trips, community repair shops, hands-on bicycle repair classes, programs for students to earn bikes, and excellent job training and internship programs.

Cycles has led over 1000 students on over 1200 bicycle field trips-everything from short trips around the block to 5 day bicycle tours of the Bay Area-and has given away over 1000 free bikes to youth and community members. For the first six years, programs were located in East Oakland, but using Measure B funds which were made available through a grant from the Alameda County Transportation Authority, they expanded their bicycle education model to new locations in Berkeley and Union City last year. Today, Cycles of Change has 14 programs located at 3 middle schools in Union City, 5 middle schools and 2 high schools in Oakland, and 2 middle schools and 2 neighborhood centers in Berkeley.

This summer Cycles of Change is planning two bicycle tours. The first is a 7-day ride exploring the Lake Tahoe area. Five staff and 15 students will tour the paths surrounding the lake, and enjoy the 4th of July fireworks display from the lake's beautiful shores. This will be

Can Routine Accommodation of Bicyclists and Pedestrians become State Policy for all Transportation Spending?

Can you think of a road project that resulted in diminished access or safety for bicyclists? Or, a new transit facility that lacked secure bicycle parking or well-planned access for bicyclists? Most of us have multiple examples. The EBBC has long had to carefully watch all so-called transportation "improvements" to make certain that they did not add yet another barrier to bicycling.

"Routine Accommodation" is our campaign to urge that all highway and transit spending consider the needs of bicyclists and pedestrians. Those of you who are familiar with the League of American Bicyclists' "Complete the Streets!" program will recognize that Routine Accommodation is a more inclusive term that encompasses transit.

The EBBC has succeeded in convincing other Bay Area bicycle advocacy leaders to unite in working toward a vision of fulfilling our goal to make all transportation spending a productive investment for bicyclists and pedestrians.

At the EBBC's 2005 retreat the Board adopted seven campaigns, including Routine Accommodation. The most exciting prospect for making Routine Accommodation a statewide policy is in Senator Tom Torlakson's Senate Constitutional Amendment (SCA-20) to require that motor vehicle fuel sales tax revenue no longer be diverted to the General Fund, but instead be spent on transportation — as was mandated in 2002 when 70% of the voters approved Proposition 42.

Governor Schwarzenegger has again proposed to suspend Prop 42 to help meet the budget deficit. The governor is asking transportation interests to cooperate as the state takes their money, in exchange for a

promise to push for future constitutional protection.

The EBBC has contacted Senator Torlakson to suggest that Routine Accommodation be included in SCA-20. The language below was drafted by former California Bicycle Coalition Director, Chris Morfas, now with CalACT, and current CBC lobbyist, Justin Fanslau.

The Department and all responsible agencies, including cities, counties, regional transportation planning agencies and transit agencies, shall fully consider the needs of pedestrians, bicyclists, and the disabled during the planning, design, construction, reconstruction or rehabilitation of highways or mass transit projects. No later than June 30, 2007, the Department, in consultation with local governments, transit agencies, law enforcement, the Department of Health Services and walking and bicycling experts, shall issue guidelines, to be updated every three years, for implementation of this section. The guidelines shall be consistent with the Policy Statement contained within the United States Department of Transportation's Design Guidance document entitled, "Accommodating Bicycle and Pedestrian Travel: A Recommended Approach."

Our efforts to build the coalition of support for Routine Accommodation have involved the Alameda County Health Department's Physical Activity Coalition. Note that another EBBC campaign is to support Health programs that promote physical activity by design of the built environment. This partnership has further led to the consideration of our language as an advocacy priority by the Bay Area Nutrition and Physical Activity Collaborative.

Please remind the Governor and your state legislators to support Routine Accommodation in SCA-20. The route to good health includes a good diet and regular exercise via walking or bicycling. Access and safety are not options in a transportation system that accommodates everyone.

Will Kempton Speaks to ITE

On February 17, 2005 while seated in the audience awaiting the start of the Institute of Transportation Engineers program, I was surprised by the keynote speaker, Caltrans Director Will Kempton, who approached with an outstretched hand and greeted me by name. "I just signed a no-bid contract for Bike to Work Day and look forward to riding on March 19," stated Kempton, a svelte 57 year-old who has posted respectable times in 10K runs. He noted his bike is "not the latest technology" and I assured him that that he will fit right in with many other novice bike commuters.

As the recently-appointed director of an organization with 22,000 employees and a \$9 billion annual budget (\$4b currently in construction in just the Bay Area), Kempton certainly has his hands full. He intends to emphasize partnerships, including community outreach, and make Caltrans into an efficient "mobility company." Regarding the Prop 42 transfers from transportation to the general fund, he commented that the "suspensions are not takeaways," and that \$5 billion in revenue will return to local coffers beginning in 2007.

He identified another strategy for success is to promote Secretary Sunne Wright McPeak's goals to link land-use decisions with transportation. Her brainchild, "Go California," is a tenyear plan that Kempton notes will soon be announced by Governor Schwarzenegger. According to Kempton, the new program includes "bicycling and pedestrian needs to create walkable, livable communities." I asked, "Will Go California routinely accommodate bicycles and pedestrians in all projects?" Kempton responded, "yes, the department already has policies [i.e., DD-64] promoting access. The Bay Bridge [East Span] is an example."

Kempton's comments offer welcome acknowledgment that Caltrans is taking their own policies seriously, plus he reaffirmed that the East Span bike path is not in jeopardy from within Caltrans. Regarding the Bay Bridge, he stated that "the skyway represents the cheapest and fastest option, while the self anchored suspension (SAS) option has unknowns. Given that the SAS was concocted prior to 9/11/2001, we also have to be concerned about the structure having inherent vulnerabilities that could result in access restrictions to the path, similar to the restrictions we currently face on the new Zampa Bridge.

BIKEWAY FOR WEST SPAN OF BAY BRIDGE needs funding. Assemblyman Leno of SF is introducing legislation to accomplish this.

HEALTH is improved by bicycling, both for the cyclist and all the breathers of air. Ala Co Supervisor Wilma Chan is supporting "Cycles of Change." Epi-

demics of obesity and diabetes can be lessened if more folks cycled.

ROUTINE ACCOMMODATIONS means adequate provisions for non-motorized transportation on all transportation projects. Prop 42 will be State Constitutional Amendment 20 to force all agencies to provide them whenever taxpayers money is spent on transportation.

4th BORE of CALDECOTT TUNNEL: We are trying to get CalTrans to consider bicycles in the environmental review. A committee chaired by Ron Bishop, the chair of Oakland's BAC, is preparing a list of mitigations, and also a field trip.

BACs should be created in all jurisdictions and transportation agencies. A new one is being created in Union City.

MOKELUMNE AQUEDUCT TRAIL NEEDS A BIKE & PED BRIDGE over the new route 4 by-pass road. Ole Ohlson reported on his ongoing struggle to get it built.

NEW BOARD MEMBER is Bill Pinkham of Richmond. Our by-laws say that at each November meeting officers and board members should be elected. All members are invited to Board meetings, and their participation is appreciated.

CoCoCo's CCTA has caused much confusion by creating a new "County-wide BAC" (CBAC) although there has been a CBAC for some 15 years in CoCoCo Public Works. Both CBAC's function is to advise the MTC on bike travel and help in apportioning taxpayers' money for bike &

ped projects. There was no communication between these two CBACs, much less was there any cooperation. It is an ongoing problem that we must force the bureaucrats to resolve, and allow more input from EBBC and other users of these projects, who are the taxpayers. A motion was passed saying there should only be only one CBAC, and that EBBC and other users should have more input, and make up a majority of all BACs.

BIKE-TO-WORK-DAY (B2WD) will be handled by the BABC this year, and they have hired an Executive Director, Nicole "Cole" Portocarrero, to help with this task. Ala Co meeting will be Fri, Apr 22. B2WD will be Thur, May 19, 2005.

CRIME The City of Berkeley is beset by bike thefts, and is planning an action to stop the crimes.

MAPS Our new East-of-the-Hills bike map is selling well in bike shops.

ADVERTISING: We voted to appropriate \$100 to help Loren Haralson pay for EBBC window stickers to be put in bike shops, a revised letter to be sent to bike shops, and a system to give members discounts in bike shops.

The second tour will take a small group of students on a 700 mile, fourteen day tour from San Francisco to Tijuana, Mexico. This ride, known as Bike-Aid, is organized by Global Exchange, a human rights non-profit based in San Francisco. On the tour, students will be a part of a 25 person group that will ride between 20 and 95 miles each day, and along the way will participate in community service projects with non-profits that focus on environmental justice. food security, militarization, and Mexico-U.S. border issues. Besides the challenge of getting physically prepared for the ride, each participant must raise \$1500. This is one of the greatest challenges facing the students (riding 700

miles being another!).

Cycles of Change has always survived because of strong support from the generosity and support of East Bay residents, and local funders such as OFCY, ACTIA and the Renaissance Foundation. Today, Cycles of Change is a project of the East Bay Asian Youth Center (EBAYC) and the East Bay YMCA, but its first fiscal sponsor was the East Bay Bicycle Coalition!

You can help Cycles of Change in a number of ways. Some ways are by donating bike parts, bicycles (small-medium sized 26 and 24 inch mountain bikes are most helpful), panniers, and bicycle gear. The easiest way to drop off donations is to bring them to the Monday Community Bike Shop at Roosevelt Middle School (corner of 20th St. and 20th

Ave. in Oakland) from 2-5:30pm. You can also volunteer to help repair youth and field trip bikes, contribute funds to support the Bike-Aid ride, or join us on one of our rides!
