In 2024, Bike East Bay helped 1,158 adults and children learn to ride with safety and confidence at 81 free bicycle skills classes in Alameda and Contra Costa Counties. Classes were offered in 24 different cities and covered 18 different topics. Our bike education classes were made possible with support from the Alameda County Transportation Commission, City of Alameda, Contra Costa Health Services and other funders.

Other programs include bike valet, volunteer, and community events.

Bike East Bay's advocacy work in 2024 resulted in big wins for people who bike in the East Bay. Our grassroots efforts paid off with 30 protected bike lanes built in 11 cities throughout Alameda and Contra Costa counties. We also engaged and trained 109 community advocates through our Green Mobility Ambassadors program and had almost 3,000 signers on our petition to preserve the Richmond-San Rafael bridge path.
